


364.973 Al (also eBook)

Alexander, Michelle. The new Jim Crow: mass incarceration in the age of colorblindness. 2010; 2012 revised; 2020 with a new Preface. A call to action for everyone concerned with racial justice and an important tool for anyone concerned with understanding and dismantling this oppressive criminal-justice system.

Anderson, Carol. White Rage: the unspoken truth of our racial divide.2016. A razor-sharp line that confronts the legacy of structural racism bequeathed by white anger and resentment-- from the Civil War to our present--while showing its continuing threat to our democracy.

Bernard, Emily. Black is the body: stories from my grandmother's time, my mother's time, and mine. 2019. Details traumas from decades past to interrogate the nuances of her own life, including surviving a stabbing and an interracial marriage. A rare book of healing.




305.89607 Brown Br (also eBook and eAudio)

Brown, Austin Channing. I'm still here: Black dignity in a world made for whiteness. 2018. Perfectly and succinctly relates anecdotes to describe the corrosive weight of white supremacy embedded within American institutions, which people of color endure on a daily basis in schools, professional spaces, and places of worship.

Buccola, Nicholas. The fire is upon us: James Baldwin, William F. Buckley, Jr., and the debate over race in America. 2019. Riveting companion to the Feb. 18, 1965 debate that swept the nation. Two opposing thinkers met to discuss: "Is the American Dream at the expense of the American Negro?" Valuable, timely insights.





Coates, Ta-Nehisi. **Between the world and me**. 2015. Structured as a letter to his teen son, both an expression of love and a cautionary tale--details what it has meant and what it means to be black in America, especially to be a black male. Hailed as a modern classic.





Crump, Benjamin. **Open season: legalized genocide of colored people**. 2019. Natl Bar Assn. president who represented Trayvon Martin's family argues that our justice system is rigged actually to harm people of color, yet believes in the power of the US Constitution to end racial injustice. Offers 12 "personal action steps." Opens our eyes.

DiAngelo, Robin. White fragility: why it's so hard for White people to talk about racism. 2018. White people feel attacked and struggle with feelings of anger and defensiveness when presented with evidence that they benefit materially from systemic white privilege. Practical tools for grappling with racism today.




306.36209 Judge Du (also eBook)

Dunbar, Erica Armstrong. **Never caught: the Washingtons' relentless pursuit of their runaway slave, Ona Judge**. 2017. Judge escaped to New Hampshire where she lived for nearly 50 years as a freewoman, despite repeated attempts by Washington to return her to his plantation. Narrative adds another perspective of our first president.

Eddo-Lodge, Reni. Why I'm no longer talking to White people about race. 2017. Since her 2014 viral blog post of the same title, she paradoxically spends most of her time talking to white people about Britain's brutal colonial history and the ways that it continues to impact race relations in the present, especially between blacks and the police.

Fleming, Crystal Marie. How to be less stupid about race: on racism, White supremacy, and the racial divide. 2018. Aims to inspire critical thinking on the past, present, and future effects of systemic racism in our institutions, and white supremacy. Insightful, irreverent text for anyone looking to question preconceived mainstream notions about race.

Kendi, Ibram X. **How to be an antiracist**. 2019. Boldly articulated, historically informed explanation of what exactly racist ideas and thinking are, and what their antiracist antithesis looks like both systemically and at the level of individual action. Should spark conversation.

Kendi, Ibram X. **Stamped from the beginning: the definitive history of racist ideas in America**. 2016. To explain the disparities that have persisted in white supremacy and black subordination, suggests that 3 sets of voices: segregationists, assimilationists, and antiracists--have defined the dominant opinions. Hopefully we can move forward by remembering the lessons of history.

Laymon, Kiese. **Heavy: an American memoir**. 2018. Race, politics, poverty, addiction, body issues, family, manhood, feminism, education—includes all of these to describe what it means to be a large black boy growing up in Mississippi, Artfully crafted, miraculously personal.

Oluo, Ijeoma. **So you want to talk about race**. 2018. As a black woman raised by a white mother, she shows how race is so interwoven into our social, political, and economic systems that it's hard for most people, even her well-intentioned mother, to see when they are being oblivious to racism. For anyone seeking to understand institutional racism.


Saad, Layla F. **Me and White supremacy: combat racism, change the world, and become a good ancestor**. 2020. Her 28-day Instagram challenge went viral. Organized by dates, with quotes, examples, and journal; prompts readers to take ownership of racist behavior and make changes that are not easy or comfortable. Groundbreaking.



353.48092 Stevenson St (also eBook, eAudio, and an Adapted Edition for Young Adults, [and a DVD feature film]


Stevenson, Bryan. **Just Mercy: a story of justice and redemption**. 2014. Founder of a legal practice dedicated to defending those in need--the poor and the wrongly condemned. One of his cases was that of Walter McMillian, a young Black man who was sentenced to

die for a notorious murder he insisted he didn't commit.



305.80097 Ta (also eBook)

Tatum, Beverly Daniel. "Why are all the Black kids sitting together in the cafeteria?" 2nd ed. 2017. First publ. in 1997. In racially mixed high schools, Black, White, and Latino youth are self-segregated in their own groups. Argues that straight talk about our racial identities is essential if we are serious about enabling communication across racial divides.



305.80097 Williams Wi (also eBook and eAudio)

Williams, Thomas Chatterton. **Self-portrait in black and white**. 2019. The seed for this memoir grew from his child's birth; with blond curls and blue eyes, would anyone know her father was Black? Her arrival prompted a self-examination, and led to his rejection of "the all-American skin game that demands you select a box and define yourself by it."
